Subject: Integration of the public selection based on qualifications and interview for the awarding of no. 2 Early-stage grants for conducting research pursuant to art. 22 of law no. 240/2010 at the Departments of University of Bergamo - Pica Code 24AR004 (Rep. No. 331/2024 of 20.03.2024)

THE CHANCELLOR

HAVING REGARD to the DR rep. n. 331/2024 of 20th March for the public selection based on qualifications and interview for the awarding of no. 2 Early-stage grants for conducting research pursuant to art. 22 of law no. 240/2010 at the Departments of University of Bergamo - Pica Code 24AR004;

TAKING NOTE THAT as part of the Public Notice for the submission of proposals for the creation of "Extended partnership to universities, research centres, companies for the financing of basic research projects" - as part of the National Recovery and Resilience Plan, Mission 4 "Education and Research" - Component 2 "From Research to Enterprise" - Investment 1.3, founded by the European Union - NextGenerationEU (Directorial Decree of the MUR no. 341 of 15.03.2022), the University of Bergamo presented, in partnership with the proponent Politecnico of Milano, the Extended Partnership in Area 11 - Made in Italy circular and sustainable "3A-ITALY";

TAKING NOTE THAT with Directorial Decree MUR no. 1243 of 02.08.2022 the results of the evaluations of the project proposals received in response to the Notice were approved and with Directorial Decree MUR no. 1551 of 11.10.2022, the Extended Partnership in Area 11 - Made in Italy circular and sustainable "3A-ITALY" project was admitted to funding;

RECALLING the Chancellor's Decrees rep. 898 prot. 161684/III/13 of 19.09.2022 and rep 1020/2022 prot. 84940/III/13 of 31.10.2022 which identified the Department of Management, information and production engineering as the structure of the University in charge of managing the project and Prf. Gianluca D'urso as the contract person for the University;

GIVEN that with resolution of 03.11.2022, the implementation methods were approved and the project code DURS_G_22_RN_MIUR_AL_3A-ITALY_01, CUP F13C22001230001 was entered in the budget of the department;

WHEREAS, after publication, it was noted that it was necessary to supplement code 2 of the above-mentioned call for proposals with a precise indication of European Union funding;

RECOGNISING the need to supplement the above-mentioned call for applications;

DECREE

Art. 1

With reference to the public selection based on qualifications and interview for the awarding of no. 2 Early-stage grants for conducting research pursuant to art. 22 of law no. 240/2010 at the Departments of University of Bergamo - Pica Code 24AR004 (Rep. No. 331/2024 of 20.03.2024), it should be noted that the allowance relating to code 2 is financed with PNRR (National Recovery and Resilience Plan) resources for Mission 4, Component 2 (Notice D.D. 341 of 15.03.2022) Extended Partnership - Title: 3A - Italy Circular and Sustainable Made in Italy - MICS (3A-ITALY)" CUP F13C22001230001, spoke 7
